5. Lifeguard Director

Congratulated the lifeguards on another successful season and recognised the new Lifeguards and Patrol Support who qualified in the last year. Thanked the team for maintaining all of the equipment during the season that ran from 7 Dec to 23 Feb with the addition of Easter Weekend. Volunteer hours were down over last year but we still had 5 rescues undertaken, 8 first aid incidents and 2718 members of the public involved in preventable actions. Ben advised he is stepping down as Lifeguard Director.

6. Junior Club Captain

The 2025 season was a great success, with around 90 participants across various age groups. Although the Rookies programme wasn't held this year (due to age and progression of participants), a strong group of 14 trainees stood out. Notably, 10 trainees successfully qualified as surf lifeguards, significantly boosting the local lifeguard team.

A team of 14 dedicated coaches focused on delivering high-quality training in beach and water safety, surf lifesaving skills, first aid, and fitness, while maintaining a fun and welcoming environment.

A major highlight was hosting one of the largest-ever Junior Surf Carnivals with over 115 participants, including strong support from other clubs. The season also saw active participation in external events such as the Pauanui Carnival, Coromandel Cup, and Oceans.

Looking ahead, goals include boosting participation, improving communication (especially around enrolment), and fostering long-term commitment to surf lifesaving.

A point of order was raised by Ross McCullough that under the current constitution general proxies are not valid. The Chairperson agreed with Ross that the proxies received were not valid and were not to be included in the vote count.
